## FACTS

### WHAT DOES VOLVO CAR FINANCIAL SERVICES U.S., LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and transaction and loss history
- Transaction history and credit history
- Account balances and payment history

#### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Volvo Car Financial Services U.S., LLC chooses to share; and whether you can limit this sharing.

These measures include computer safeguards and secured files and buildings.</p> <p>Our customers' information is accessible only by appropriate personnel who have a business need for the information. We provide training and communication programs to educate our personnel about the meaning and requirements of this privacy notice.</p>

<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account.

Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Volvo Car USA, LLC</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>• <i>Nonaffiliates we share with include authorized Volvo motor vehicle retailers.</i></li> </ul>
<b>Joint marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>• <i>Our joint marketing partners include insurance companies, other financial and nonfinancial providers/servicers.</i></li> </ul>

Other important information	
<p><b>Vermont Residents</b> - We will not share any of the personal information that we collect about you without your express written consent, except as otherwise explained in this notice.</p> <p><b>California Residents</b> -The notice above pertains to nonpublic personal information under the federal Gramm-Leach Bliley Act ("GLBA"). The State of California has enacted the California Financial Information Privacy Act which states that the policies intended to protect financial privacy imposed by the GLBA are inadequate to meet the privacy concerns of California residents. A separate California law, the California Consumer Privacy Act ("CCPA"), as amended by the California Privacy Rights Act ("CPRA"), addresses information that is covered by the CCPA which excludes information subject to the GLBA. We may share your nonpublic personal information subject to the GLBA with companies that are related by common ownership or control (affiliates) and authorized vehicle retailers.
